#### U.S. CURRENCY READER PROGRAM TO HELP PEOPLE WITH VISION DISABILITIES

The Department of the Treasury's Bureau of Engraving and Printing (BEP) is now accepting applications from people who have vision disabilities and wish to receive a currency reader to denominate U.S. currency. U.S. citizens or individuals legally residing in the U.S. and its territories who have vision disabilities can obtain a currency reader device at no cost. The currency reader, known as the iBill® Talking Banknote Identifier, is compact in size, easy to use, and provides a response within just a few seconds. A user simply inserts a Federal Reserve note into the device, presses a button on the side, and the reader identifies the denomination. The device operates on a standard AAA battery and can read U.S. currency in circulation today. The reader can be set to indicate the note's denomination by voice, a pattern of tones or series of vibrations.

## ACHIEVING A BETTER LIFE EXPERIENCE (ABLE) ACT



Vice President Joe Biden Last week, Vice President Joe Biden hosted an event at the White House with Members of Congress to highlight the benefits and achievements of the ABLE Act. TASH's Barb Trader was in attendance to celebrate its' signing into law.

The ABLE Act, signed into law on December 19, 2014, creates a new savings account for families with people with disabilities. These tax-preferred accounts allow families to save for future disability-related expenses without losing Medicaid and Social Security benefits.

Many families are now wondering when they can create their ABLE accounts. The answer?; not so fast. The Secretary of the Treasury must issue regulations or other guidance sometime between now and mid-June. Once the regulations have been approved, each state will then decide whether to offer an ABLE account, and if so, whether it will be state-run or managed by another entity, such as a financial services firm. A state could also opt to contract with another state and allow its residents to use an ABLE program from another state.
